WHEREAS, E. N. Mette, as Administrator, has filed his actions a-
gainst Dorsey Allen, et al, and whereas Robert Neal has heretofore
in this court, filed his actions against Ellen Stewart, et al, and both
cases have been consolidated and were heard before Harry H. Harris
Esq., as special master, and whereas, a consent decree was taken by
which the master for the sum of \$300.00, is to make deed to Evelyn Mette, to the real
estate described below. 15th day of September in the year of
our Lord nineteen hundred and fourteen exhibited his complaint in the Court
of Common Pleas, for the County aforesaid, against

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

Evelyn Mette:

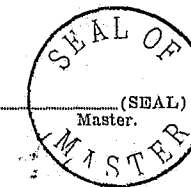
All that lot of land in ward six of the City of Greenville,

for Yorkville County, in Book "777" page 482, described therein

the following lines: Beginning at a point on Glee Street,
corner of lot No. 14, thence with line of lot No. 13 and 14, 100 feet to
corner of lot Nos. 13 and 9, thence with line of lot No. 9, 30 feet;
thence back to Glee St., 100 feet; thence with Glee St. 30
feet to the beginning.
