(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto  
the said C. S. Barbare

all that certain parcel and tract of land situate lying  
and being in South Carolina, Greenville County, Chick Springs  
Township, on public road, leading from Taylors, past St. Mark  
Colored Church, adjoining land of G. W. Hill, Mrs. Laura Crowder  
W. Vance Crowder & others, having the following notes & corners  
to wit: Beginning on said public road, in front of W. V. Crowder's  
residence, S. 69 3/4 W. 9.22 chs. to a stone, W. V. Crowder's
