All that certain lot or parcel of land in the County of Greenville, in the State of South Carolina designated as lot #3 in Block 6 as described on the plat of the land of the Melville Land Co., recorded in office of R.M.C. for Greenville County in the plat book, page 47. Above described lot being a part of the subdivision of the land sold to the Melville Land Co. by L. C. Boling, conveyed to J. E. 
