NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Louis Mason

in the State aforesaid

in consideration of the sum of Fifty Seven Hundred DOLLARS,

to me in hand paid at and before the sealing of these presents by J. E. Lawrence

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said J. E. Lawrence, all that portion of land situate in the said State, Greenville County, Chick Springs Township, 7 miles west of the town of Greenville, on the old road leading from the Chick Springs road to the old running house place, and having the following written and bounded; Beginning at an iron pin on the side of said road and running at an angle five rods to the side of said road and running 26 1/2 E. 16 1/2 C. to a large pine tree; thence 26 8 1/2 N. 4 1/2 E. to an iron pin; thence S. E. 16 1/2 C. along said old road to the beginning corner, and containing five acres more or less, also all that other piece, parcel or lot of land situate lying and being in the State and County aforesaid, containing twenty-two acres more or less and being the same tract of land conveyed to L. R. Mason by Mary F. Pease in deed running date 1/10/30, 1912. For further particular description reference is hereby made to said Deed.
