Wright*, all that certain piece, parcel or lot of land, in County and State aforesaid, in Greenville Township and being a part of the lands of the Riverside Land Company, said lot being known and designated by a plot of said lands as lot six (6) said plot being recorded in P. M. C. office for Greenville County and Plat Book "A" at page 323 the same having a frontage of fifty feet on Calmette Avenue and a depth of one hundred and twenty-five (125) feet to any alley and being one of the lots conveyed to me by J. Frank Miller.

It is distinctly understood and agreed by the parties hereto that this conveyance is made subject to the conditions expressed in the deed from the Riverside Land Company to J. Frank Miller.
