NOW, KNOW ALL MEN BY THESE PRESENTS, That J. L. Milford
in the State aforesaid
in consideration of the sum of Eight Hundred (\$800.00) DOLLARS,
to me in hand paid at and before the sealing of these presents by
Barrie Turner,

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Barrie Turner, "all that certain piece, parcel, or lot of land situate, lying and being on Stotter Street in ward six of the City and County of Greenville, State of South Carolina, and having a frontage on Stotter Street of 42 feet, rear line being 54 feet, with side lines as follows; north line 146 feet and south line 151 feet, being lot #4 of the subdivision of the Peterson lot, plat of which was made by W. D. Neves on June 18th, 1910, said lot contains 7104 square feet, more or less."
It is understood and agreed by the grantor and grantee herein, that four feet is reserved on the south side of this lot, which with four feet from the adjoining lot belonging to the grantor, is to be forever kept open as an alley for the use of the grantor, his heirs and assigns, and the grantee, her heirs and assigns.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
Barrie Turner, her heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said
Barrie Turner, her heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
