in consideration of the sum of Five Dollars and other valuable consideration in the State aforesaid
to me in hand paid at and before the sealing of these presents by
N. R. Lowe

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

N. R. Lowe, his heirs and assigns, all that certain lot of land, known as lot no. 32 in Oakland Heights, in the City and County of Greenville, South Carolina; Beginning at an iron pin 60 feet from the southeast corner of Oakland and Choice Street, and running thence S. 34.50 W. 150 feet to an iron pin on lot no. 37, thence with line of lot 37 S. 62.19 E. 60 feet to a pin, corner of lot 33, thence with line of lot 33 N. 34.50 E. 150 feet to a pin on Choice Street, thence with Choice Street N. 62.19 W. 60 feet to the beginning corner, being one of the lots conveyed to me by S. O. Stover by deed dated the 20th. day of December 1916 and recorded in Vol. 41 Page 554.
