Hightower, all my right, title and interest (same being a one-fourth interest) in and to: All that certain piece, parcel and tract of land situate, lying and being in Greenville, State of South Carolina, on waters of South Syger River, containing sixty-four acres, more or less and bounded by lands of B. J. Stewart, A. J. Southern and others and being the same interest inherited by me from my father, M. S. Hughes, deceased.

Avery B Hightower, his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
