(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
W. W. Medlin all that certain piece, parcel or lot of land situate in the state and county aforesaid and having the following metes and bounds to-wit: Beginning at a point on box street and runs thence n. 16.50 w. 134 feet to a stake; thence S. 76.15 w 60 feet to a stake; thence S. 16.50 E. 135 feet to box street; thence along the said box street n 75 E 60 feet to the beginning corner, being Lot #18 on a plat of land called "Willcrest" made by Will D. Neves.
also all that other piece, parcel or lot of land situate in the state and county aforesaid, and having the following metes and bounds to-wit: Beginning at a point on box street, corner of Lot #18 and runs thence with said lot n 16.50 w. 135 feet to a stake; thence S 76.15 w. 60 feet to a stake; thence S. 16.50 E 136.8 feet to said box street; thence n 75 E 60 feet to the beginning corner, being Lot #19 on above described plat.
