 in consideration of the sum of *Fifteen Hundred and no/100* DOLLARS,  
 to *me* in hand paid at and before the sealing of these presents by *L. N. Littlefield*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said *L. N. Littlefield*, all that piece, parcel or lot of land situate lying and being in the State and County aforesaid, in the Parish of *Greenville*, and having the following metes and bounds: Beginning at a point on *Beehow Street* and running thence *N 33 3/4 E 1111 feet* to a point at the intersection of *Beltham Road* and *Randall Street*; thence with *Randall Street N 55 1/2 W 90 feet*; thence *S. 33 1/4 W 112 feet* to *Edward's line*; thence with his line *S. 54 1/2 E. 90 feet* to the beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises, belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said *L. N. Littlefield, his* heirs and assigns, forever.
