 in the State aforesaid,
 in consideration of the sum of Two Hundred & Forty-one DOLLARS,
 to me in hand paid at and before the sealing of these presents by C. S. Poole

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said C. S. Poole, all that piece, parcel and tract of land lying situate and being in the state and County aforesaid, known as part of the land conveyed to me by deed from Francis Hawkins, adjoining lands of Mrs. Nancy Ellic McKinney and others. Bound as follows; Beginning on a stone on Mill Road, thence N. 76 1/2 W. 15.00 to a bridge on said road; thence S. 16 W. 240 to the creek; thence down creek S. 81 1/2 E. 6.23 to a Black Gum; thence S. 15 E. 19.10 to a spring; thence S. 26 E. 6.40 to a stone on; thence N. 84 E. 13.30 to a stone; thence N. 9 W. 24.40 to the beginning corner and contains (19 1/2) nineteen and a half acres bet the same more or less.
