NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Mrs Sallie Noble of Greenville County, in the State aforesaid, in consideration of the sum of Two Thousand and no/100 (\$2,000.00) DOLLARS, to me in hand paid at and before the sealing of these presents by Marvin Rollins

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Marvin Rollins, and his heirs and assigns, All that certain piece parcel or tract of land situate, lying and being in the State of South Carolina, and County of Greenville, in Oneal Township, and having the following metes and bounds, to wit: Beginning on a stone Bull's corner and running thence N. 29 1/4 W. 4.18 to a stone, thence along settlement Road bearing from Sandy Point to J. W. Coville 12.35 along said road to a stone (new corner), thence S. 21 1/2 E. 37.80 to a stone on old road, thence S. 45 1/2 W. 6.85 to a stone in said road; thence S. 57 W. 3.65 to a stake in branch (on said road back to the Bull corner), thence S 44 1/2 W. 11.60 to a stone; thence S. 45 E. 10.78 to a poplar; thence S. 43 1/2 E. 18.24 to stake in branch the beginning corner and containing 56-4/100 acres more or less, and bounded by lands of R. L. Anderson, J. D. Bull, R. L. Dill and others, This being the same tract of land conveyed to me by J. T. Carlton by his deed dated Jan. 30th, 1906, and recorded in the R. M. C. office for said County and State in deed Book "R. R. R." at page 557, to which reference is hereby made.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

Marvin Rollins, his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Marvin Rollins and his

heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
