(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

*J. B. Williamson in all, and his certain lot, piece or parcel  
of land situated in County and State aforesaid, and  
on Northeast side of Jordan Road beginning at an  
iron pin in center of said Jordan Road at corner  
of J. B. Benson's land and runs thence N. 43 $\frac{1}{2}$  E. 21.39  
chains to a stone, thence N. 84 $\frac{1}{2}$  E. 6.33 to a stone  
thence S. 3 $\frac{1}{2}$  W. 21.30 to a stone in Henry Briggs' line  
thence S. 50 $\frac{1}{2}$  W. 21.30 to an iron pin in J. Jordan Road  
thence with said Jordan Road to the beginning corner
