 County of *Greenville* and in the State aforesaid,
 in consideration of the sum of *Seven hundred and Seventy Five and 100/100* DOLLARS,
 to *me* in hand paid at and before the sealing of these presents by *J. K. Peden*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
J. K. Peden, his heirs and assigns for ever, all that certain
 piece parcel and lot of land, situation, lying & being in the
 County and State aforesaid, at *Paris* about four miles from
 the City of *Greenville* and being a part of lot #4 made by
 plat made by *Reid* and *Beal* in 1913, and being a
 part of the lot of land conveyed to me by *M. W. Williams*
 by deed dated Oct. 6th, 1914 and recorded in Deed Book
 43 page 183 R. M. C. Office for Greenville County State
 aforesaid. Beginning at a stake on *Wich Springs Road*
 75 feet from the corner of lot #4 and #5 and running
 thence down said road in the direction of *Glick*
Springs 25 feet to lot #3; thence in a westerly
 direction 105 feet to a stake; thence in a southerly
 direction 25 feet to a stake 75 feet from the line of
 lot #24; thence in a straight line in a south-
