Haynesworth, of the County of Greenville, in the State aforesaid, in consideration of the sum of Five Dollars and other valuable consideration DOLLARS, to me, in hand paid at and before the sealing of these presents by H. M. Jordan, J. B. Cunningham and F. H. Cunningham

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said H. M. Jordan, J. B. Cunningham and F. H. Cunningham All those certain lots of land, fourteen (14) in number, situate in the County and State aforesaid in the subdivision known as "Riverside" and designated on plat of said subdivision as lots Nos. 1 to 14 inclusive, in Block B. B. fronting on Chicora Avenue, and having the following frontage on said Avenue; to-wit; Lots Nos. 1, 2, 4, 9, and 10, each 50 ft.; Lot No. 3, 40 ft.; Lots Nos. 5, 6, 7, 8, each 51 1/2 ft.; lots Nos. 11, 12 and 13 each 60 ft. and lot No. 14, 30 ft. The latter lot fronting on the street car line 128 1/2 ft.
