NOW, KNOW ALL MEN BY THESE PRESENTS, That I, 10. H. Moore
in consideration of the sum of Ten Dollars and other valuable consideration in the State aforesaid,
to me in hand paid at and before the sealing of these presents by H. H. Hunt

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

H. H. Hunt, his and assigns, all that certain piece parcel, or tract of land, situate, lying and being in the County of ~~Greenville~~ and State aforesaid on the New Lowndes Mill Road, about two miles East from the City of Greenville, and having the following lines metes and bounds, to wit: Beginning on an iron pin in the center of the New Lowndes Mill Road and running thence N. 17-23 W. 5-35 to a stone; thence N. 36-56 W. 11.00 to a stone; thence N. 21-30 W. 17.65 to an iron pin; thence N. 45-42 E. 11.98 to a stone; thence S. 53-29 E. 4.00 to a stone; thence S. 68.50 E. 30.30 to a stone; thence S. 67-45 W. 28.00 to a stone; thence S. 22-18 E. 14.80 to an iron pin in the center of the New Lowndes Mill Road; thence along the center of said road N. 86-51 W. 1.50 to fence in the same; thence S. 71-32 W. along the center of road to the beginning, containing sixty acres, more or less, and being the same tract of land conveyed to me by W. P. Merritt and D. L. Dostey, deed dated the 9th day of December 1912, and recorded in Vol. 20, page 468.
