 NOW, KNOW ALL MEN BY THESE PRESENTS, That I, A. C. Lee

in the State aforesaid,
 in consideration of the sum of Five Hundred Fifty DOLLARS,
 to me in hand paid at and before the sealing of these presents by
A. A. Roddy

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

A. A. Roddy. All that certain piece parcel or lot of land, situated, lying and being in the State and County aforesaid about 3 miles from the Greenville County Courthouse, in section known as "City View" and being known and designated as lot No. 3, according to a plat of said lot as shown in Plat Book "C" page 112 and having the following courses and distances;

Beginning at a stake, joint corner of lots Nos. 2 and 3 and running thence in an Easterly direction with O'Neal Ave. 65 feet to a stake joint corner of lots Nos. 3 and 4 thence in a Southerly direction with said joint lines 170 feet to a stake; thence in a Westerly direction 67 feet 10 inches to a stake joint corner of lots Nos. 2 and 3; thence with said joint lines in a Northerly direction, 170 feet to the beginning and being one of the said lots as conveyed to me, the said A. C. Lee, by T. F. Hunt, by his deed dated May 14, 1912 and recorded in Vol. 19 page 312, office of R. M. C. Greenville County

A. A. Roddy, his heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
