 NOW, KNOW ALL MEN BY THESE PRESENTS, That E. H. Holliday
 in the State aforesaid,
 in consideration of the sum of One Thousand Six Hundred & twenty DOLLARS,
 to me in hand paid at and before the sealing of these presents by Dexter A. Huff

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Dexter A. Huff and his heirs and assigns forever, one certain tract or parcel of land containing forty acres, be the same more or less, it being a tract of land formerly belonging to the Estate of Mrs Susan Ramsey, and which was deeded to me by J. M. Coy & Fred W. Coy as Executors of the Estate of Susan Ramsey, in a deed bearing date November 20th. 1914, and which is recorded in the Register's office for Greenville County, in Vol. 51 page 16. further described as follows: Beginning on a stone 3 1/2 with land belonging to R. Dawkins now Mrs J. P. Cothran, thence S. 35 1/2 E. 5.33 chains to a stone 3 1/2 thence S. 18 3/4 E. 25 chains to a stone 3 1/2 thence S. 80 1/2 W. 24.50 chains to a Sycamore 3 1/2 on Cedar Shoals Creek, thence up the creek, the creek being the line 17.50 chains to a stake 3 1/2 with the Dawkins Mullikin tract thence S. 75 1/4 E. 6.25 chains to a stone 3 1/2 thence N. 8 1/4 E. 24 chains to the beginning corner.
