(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

*J. D. Bridges*, all that certain piece parcel or lot of land situate lying and being in Ward 4 of the City of *Greenville*, County of *Greenville*, and State of *South Carolina*, and having the following meter and bounds, to-wit: Beginning at a point on *Webster Street*, corner of the lot heretofore conveyed by me to the said *J.
