NOW KNOW ALL MEN BY THESE PRESENTS, That I Rebecca C. Neal

in the State aforesaid, in consideration of the sum of Ten (\$10.00) and other valuable considerations DOLLARS, to me in hand paid at and before the sealing of these presents by Eugene C. Honow

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Eugene C. Honow.

All that certain lot or Parcel of land situate lying and being just without the corporate limits of the City of Greenville on the Northern side of Perry Avenue and having the following metes and bounds to wit:

Beginning at a iron pin on the north side of Perry Ave. corner of lot sold S. W. Klams and running thence with line of his lot 137 feet, more or less, to an iron pin thence in an easterly direction 53 feet to an iron pin, thence in line parallel to the first line and in a southeasterly direction 137 feet, more or less, to an iron pin on Perry Ave. which iron pin is 53 feet from the beginning corner; thence in an easterly direction with Perry Avenue 53 feet to the beginning corner and being a portion of the lot of land conveyed to me by my mother, Rebecca C. Honow on the 22nd day of September 1908 and known as a portion of lot 66 of Redington Heights.
