 in consideration of the sum of Six hundred and fifty DOLLARS,
 to me in hand paid at and before the sealing of these presents by E. F. Henderson

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said E. F. Henderson, all that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, in Grove Township, containing seven and one-half acres more or less and being the same conveyed to me by J. R. Henderson by deed recorded in R. M. Office for Greenville County in Vol. J. T. T., page 654. Said tract of land is described as follows: Beginning at a stone in the road, thence N. 43 3/4 E. 11.62 to an iron pin in the Piedmont Road; thence with said Road S. 78 1/4 E. 12.90 to an iron pin; thence S. 53 1/4 W. 14.72 to the beginning corner, bounded by lands of T.
