(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Harry Pool  
All that piece parcel and tract of land lying, situate and being in Bates Township State and County aforesaid known as a part land conveyed to me by deed from George W. Bishop, adjoining lands of myself, Harry Pool and others, Beginning on a stake, thence running N. 58 W. 4.75 to a Dogwood 37 on, thence S. 35 1/2 W. 13.50 to a H.O. 73 on Branch, thence down the Branch 12.50 to a H.O. 7 new mark, thence N. 23 1/2 E. 21.25 to the beginning corner and contains 11 3/4 acres, be the same more or less, I hereby except the saw timber on the above described place.
