V. M. Johnson (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

V. M. Johnson, all those four lots of land in the City of Greenville, County and State aforesaid on the west side of Anderson Street, fronting said Street 201 feet more or less, and running back a depth of 150 feet, being lots Nos 2, 3, 4 and 5 of a subdivision of the Nelson lands and being the same lots conveyed to me by E. Juman Master, deed dated August 20 1918 and conveyed to F. B. Mc Bee by Kate Nelson deed dated March 1st 1915 and recorded in R. M. C. office for Greenville County in Vol. 23 page 576.
