R. B. Jones All that piece parcel or lot of land
 situate lying and being in Greenville County in State

 of Townes Street beginning 112 1/2 feet north from
 intersection of Marshall Avenue and Townes Street
 having a frontage of 37 1/2 feet on Townes Street
