NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Christine Holliday of the State and County aforesaid, in the State aforesaid, in consideration of the sum of Forty five hundred + no/100 DOLLARS, to me in hand paid at and before the sealing of these presents by J. A. Floyd

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said J. A. Floyd, all that certain piece, parcel and tract of land situate, lying and being on the White Horse Road, about three miles from the City of Greenville, containing fifteen acres, more or less, being lots nos. 2 and 3 of the tract of land conveyed to P. S. Butler by W. H. Springs and others as per survey of J. M. Southern of date July 1st 1907. See Plat Book No. 1 page 165 R. M. C. Office for Greenville County and being the same land conveyed to J. E. Little by P. S. Butler by deed dated August 10th 1907 and recorded in said Office for said County in Volume W. H. W. page 72 and to Thos R.
