in the State aforesaid,
in consideration of the sum of *Sixteen Hundred + Fifty $\frac{3}{4}$* DOLLARS,
to *me* in hand paid at and before the sealing of these presents by *J. A. Pitman*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
J. A. Pitman, all that piece parcel and tract of land
lying situate and being in *Bates Township*, State and
County aforesaid.

Known as a part of the land conveyed to me by deed
from *Mrs. H. L. Dae Jr.*, adjoining lands of myself, *G. W. Morgan*
and others. Beginning on a stone *G. W. Morgan's*
corner running thence *N. 89 1/2 W 48.50* to a stone thence *S.*
22 1/4 E. 4.50 to a stake in branch, thence *S. 80 E. 15.63* to
a *W. O. X S. N. M* thence *S. 67 E 23.00* to a stone on the white
Horse Road as the line *18.60* to the beginning corner,
