NOW, KNOW ALL MEN BY THESE PRESENTS, That I, E. B. Curry in the State aforesaid,
in consideration of the sum of thirty three hundred and fifty DOLLARS,
to me in hand paid at and before the sealing of these presents by

Elizabeth H. Long
(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Elizabeth H. Long, her heirs and assigns, all that lot of land situate just North of the City of Greenville, State and County aforesaid, and known as lot No. 5 in Highland Terrace; as known by plat recorded in Plat Book C, Page 102 and described as follows: Beginning on Hill Crest Drive at Corner of lot No. 4 and runs thence along the South side of said street N. 66.30 W. 75 feet to an iron pipe, corner of lot No. 6, thence with line of lot No. 6, S. 23.30 W. 190 feet to an iron pipe ten feet from property line of Windman and Roster; thence along a line 10 feet North of said property line S. 66.30 E. 75 feet to an iron pipe, thence, with line of lot No. 4, N. 23.30 E. 190 feet to the beginning corner and being the land conveyed to me by Lucia d. Windman, by deed the day of May 1917 and recorded in Vol. 46, page 247.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

Elizabeth H. Long, her heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
