 NOW, KNOW ALL MEN BY THESE PRESENTS, That Robert Wilson of the County of Greenville in the State aforesaid,
 in consideration of the sum of Ten Dollars and other valuable considerations
 to me in hand paid at and before the sealing of these presents by

Charlotte Tripp
 (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Charlotte Tripp All that certain lot or parcel of land situate lying, and being in the County and State aforesaid near the City of Greenville, known and designated as lot no 298 of the McCarry land as shown on plat of record in the R. M. C. Office for Greenville County in Plat Book A. at pages 278 and 279. This lot is on the south side of McCarry Street and is 66 ft. in width and, approximately, 112.3 ft. in depth on the west side and 112 ft. on the east side, according to said plat being the same lot of land conveyed to me by P. S. Butler on the 20th day of June 1908, deed being of record in Vol. 333, page 76 and subsequently conveyed to me by way of quit claim deeds from P. S. Butler on March 16, 1916 deed of record in Vol. 39 page 245, and quit claim deed of M. P. Bradley and J. H. Bailey on March 16 1916 deed being of record in Vol. 39 page 244.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Charlotte Tripp her heirs and assigns, forever.
 AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Charlotte Tripp her heirs, and against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
