All that certain piece, parcel or lot of land, situate lying and being in the State and County aforesaid, in *Chick Springs Township*, near the Town of *Greer* and on the North side of *Emma Street* being lots #5 9, 10, 57, 58 as shown on a plat of land known as *Morrow Park* which was surveyed for *C. L. Chandler* by *A. E. Hoffman*, March 1918, same being recorded in office of *R. M. C.* for *Greenville County* in Plat Book *D*, Page *91*
