 in consideration of the sum of Eighteen Hundred DOLLARS,
 to me in hand paid at and before the sealing of these presents by Jasper M. Page

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Jasper M. Page, All that certain piece, parcel, or house and lot, situate, lying and being on Dance Street, near Woodside Mills, in Greenville County, in Greenville Township, just outside of the City limits of Greenville, and in the Town of West Greenville, S. C. known as lot No. 35 on plat of lands of M. M. Nowood, known as Nowood Heights, made by J. N. Southern, Surveyor dated October 9th - 1906 and recorded in office of R. M. C. for Greenville County S. C. in plat book "A" page, 133, said lot has a frontage of fifty (50) feet on Dance Street, and is one hundred and fifty (150) feet deep, and is the same lot of land conveyed to me by M. A.
