in consideration of the sum of Ten Dollars (\$10.00) and other consideration in the State aforesaid,
to me in hand paid at and before the sealing of these presents by Mary R. Holliday

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Mary R. Holliday, her heirs and assigns,

All that certain piece, parcel or lot of land situate lying and being in the County and State aforesaid and being known and described more particularly as lot #67 of Morgan Hill Addition, fronting sixty (60) feet on Blamlett Road and running back in parallel lines to a depth of Two Hundred feet (200). Plat of the same being recorded in R. M. C. office for Greenville County in Plat Book "A" at page 168 + 69, and being a part of the same land conveyed to me by deed recorded in Vol. S.S.S. at page 386.
