in consideration of the sum of Twelve Hundred Dollars DOLLARS,  
to me in hand paid at and before the sealing of these presents by W. W. Collier

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said  
W. W. Collier, all that certain lot of land situate on the  
south side of West Earle Street in the First Ward of  
the City of Greenville, County, and State aforesaid,  
known and designated as lot no. 12, as shown on  
plat of property of W. W. Miller, by R. C. Dalton, Engineer,  
dated April 1919, and having the following metes  
and bounds, to-wit: Beginning at an iron pin on  
the south side of West Earle Street say hundred  
and fifty-five (655) feet from the intersection of  
Robinson and Earle Streets, joint corners of lots  
nos. 11 and 12, and running thence along line  
of lot no. 11, S. 2-46 W. 185.2 feet to an iron pin;  
thence N. 84-19 W. 58.5 feet to an iron pin; thence  
N. 2-16 E. 184.2 feet to an iron pin on Earle Street;  
thence with Earle Street S. 85-38 E. 60 feet to the
