in consideration of the sum of Ten Dollars + other Valuable Consideration \$10.00 DOLLARS,
to us in hand paid at and before the sealing of these presents by W. M. Reid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
W. M. Reid his heirs and assigns, All that certain piece
parcel or tract of land situate lying and being in State
and County aforesaid on water of Beaderdam Creek
having the following full meter and bounds to-wit:
Beginning at an ash running thence S. 53 E. 23.50 to
W. O. on State road thence S. 10 W. 3.20 to a Stone on
said road, thence S. 71 3/4 W. 19.00 to a stone, thence N.
31 1/4 W. 34.50 to a pine, thence N. 27 E. 5.13 to a Stone
thence S. 57 E. 17.82 to the beginning corner, said
boundary, containing fifty acres more or less.
