NOW, KNOW ALL MEN BY THESE PRESENTS, That I, N.H. Harris
in the State aforesaid,
in consideration of the sum of Eight hundred and fifty DOLLARS,
to me in hand paid at and before the sealing of these presents by
Julia G. Williams

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
Julia G. Williams, her heirs and assigns, All that lot of land situate on the North side
of Edwards Street, in the City and County of Greenville, S.C. fronting said Street 60 feet
with a depth in parallel lines 114 feet to an alley, being lot No. 22 as is shown on plat of
Mrs. F.E. Harris Estate, recorded in Plat Book C., page 261, and has such courses and distances
as is shown by said plat.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
Julia G. Williams, her heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and
forever defend, all and singular, the said premises unto the said Julia G. Williams, her

heirs and assigns, against myself and my heirs, and against
every person whomsoever lawfully claiming or to claim the same, or any part thereof.

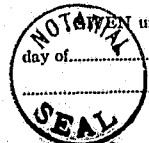
