 NOW, KNOW ALL MEN BY THESE PRESENTS, That the Agnes O Stone and E E Stone
of the County of Greenville in the State aforesaid,
 in consideration of the sum of Five Hundred DOLLARS,
 to us in hand paid at and before the sealing of these presents by Lena W Stone

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Lena W Stone, all that certain piece, parcel or tract of land situate, lying and being in the State and County aforesaid about three miles from Greenville Court House, and about three hundred feet north of the Concrete Road and described as follows, to wit:

Beginning at the intersection of Edgewood Avenue and an unnamed Street and running thence in a north westerly direction with Edgewood Avenue three hundred fourteen (314) feet to a stake; thence N. 43-30 W. two hundred ninety eight (298) feet to a pin in said un-named street; thence with said unnamed street in a southerly direction four hundred eighty two (482) feet to the beginning corner and containing 1.29 Acres and being lot No. 21 of a plat of Croftstone Acres said plat recorded in R.M.C. Office in Plat Book "E", page 35-36
