 in the State aforesaid,
 in consideration of the sum of Forty-five hundred DOLLARS,
 to me in hand paid at and before the sealing of these presents by
T.J. Allen,

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
T.J. Allen, his heirs and assigns, All that certain piece, parcel and lot of land lying, and being in Austin Township, County and State aforesaid and located in the eastern part of the Town of Simpsonville and having the following metes and bounds, to-wit: Beginning at iron pin in center of Georgia Road and running thence N. 18-3/4 E. 18.93 to iron pin; thence S. 79-1/2 W. 3.50 to iron pin; thence S. 18-3/4 W. 16.47 to iron pin, J.D. Meadors corner; thence S. 13-1/2 W. 3.46 to iron pin in center of said Georgia Road; thence N. 87 E. along said road to the beginning corner, containing about 5.80 acres, more or less, and bounded by lands of Dr. A.S. Howard, S.T. Moore and B.W. Burdett, and being the major part of same tract of land conveyed to me by Mrs. Nelle A.  TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said T.J. Allen, his heirs and assigns, forever,

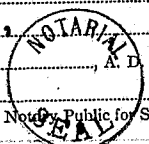
