(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

P.F. Lindsey, All that certain piece, parcel, tract of land situate, lying and being State and County aforesaid on both sides of Tugaloo Road, joining lands of C.G. Dill and R.L. Lindsey and others: Beginning on a stone S. of R.L. Lindsey and running thence S. 75 W. 18.50 to a stone or stake; thence N.E. to a stone or stake; thence N. 3-1/2 E. 32.31 to a stake at turn of Glassy Mountain Road; thence along said road S. 50-1/3 E. 22.49 to a stone; thence S. 12 W. 9.04 to a stone on Tugaloo Road; thence S. 9 E. 4.50 to beginning corner containing forty (40) acres, more or less, being the same land conveyed to me by J.A. Lindsey by deed dated May 27, 1917 and recorded in Vol. VVV, page 382 in R.M.C. Office for Greenville County.
