(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said W. A. Merritt and J. E. Johnston, their heirs and assigns, all my right, title and undivided one third (1/3) interest, of, in and to all that tract or parcel of land situate in the County of Greenville, in said State, and has the following metes and bounds, to-wit: beginning at a stone 3x12 (in place of a stake), at J. H. Howard's corner, and running thence N. 59 3/4 E. 28.40 to a stone 3x12, by a large black oak, thence N. 26 1/2 W. 12.37 to a stone 3x12; thence S 63 1/4 W. 12.34 to a pine stump 3x12; thence N 27.1 W 43.90 to a stone 3x12; thence S 63 1/4 W. 17.61 to a Post Oak 3x12; thence S 28 3/3 E. 58.14 to the beginning corner, adjoining lands of Brown estate, Howard and others, and containing one hundred, eleven and three fourths (111 3/4) acres, more or less, and being the same land conveyed to W.
