NOW, KNOW ALL MEN BY THESE PRESENTS, That W. A. Bates of the City and County of Greenville in the State aforesaid

In consideration of the sum of Two Hundred and Twenty Five DOLLARS, to me in hand paid at and before the sealing of these presents by Sam Hill and Rebecca Hill

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said Sam Hill and Rebecca Hill, their heirs and assigns

forever, all that certain piece, parcel or lots of land, situate lying and being in Greenville County, near the City limits of Greenville, State of South Carolina; Beginning at an iron pin on the south side of Foster Street, corner of lots 13 and 14, running thence north with Foster Street 72.15 W. 52 feet to an iron pin, corner of lot 16, thence with the dividing line of lots 15 and 16 S. 31.18 W. 55.3 feet to an iron pin, corner of lots 3 and 4, thence with the dividing line of lots 4, 5, 14 and 15, (in a south easterly direction) 82 feet to an iron pin, corner of lots 6 and 13, thence with the dividing line of lots 13 and 14 N. 30.54 E. 80.2 feet to an iron pin, in a side of Foster Street, the beginning corner, and being lots nos. 14 and 15 as shown on plat and survey made by Will D. (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said J. L. Haley, All that piece, parcel and lot of land

situate, lying and being in Greenville City, County and State aforesaid, in Ward Six, on Grove Street, and known as lots nos. 8 and 21, as shown on plat made by W. A. Hudson, March 21st, 1906, and recorded in the R. M. B.
