(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said SUCY B. PERRY, all that certain piece, parcel or lot of land, situate in the State and County aforesaid, in Ward One of the City of Greenville, and being known and designated as Lot No. 7, according to a plat made by R. E. Dalton, Engineer, December, 1916 and lying on the west side of Wilson Street, said street running off from Woodwin Street and having the following limits and bounds to wit:
