NOW, KNOW ALL MEN BY THESE PRESENTS, That J. J. Hunt of Greenville City in the State aforesaid in consideration of the sum of Five Dollars and other Valuable Consideration DOLLARS, to me in hand paid at and before the sealing of these presents by J. H. Dean and S. L. Calder (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said J. H. Dean and S. C. Calder, their heirs and assigns, All that lot, piece or parcel

of land situate, lying and being in the County and State aforesaid, near the Eastern Limits of the City of Greenville and near the Spartanburg Road and being a part of a sub-division of land of Martha J. Howell.

Beginning at a stake on Street and running thence N. 67 E. 84.5 ft. to a stake corner of lot No. 9; thence N. 55-1/2 E. 222 ft. to a stake, corner of Lot No. 9; thence N. 9-1/2 W. 86-1/2 ft. to a stake, corner of lot No. 11; thence S. 67-1/2 W. 290 ft. to a stake, corner of lot No. 11 and St.; thence S. 9- E. 118 ft. to the beginning corner, being known as lot No. 10 according to a plat made by W.A. Adams, Surveyor, and recorded in Plat Book C., pages 154 and 155 and being one of the lots conveyed to T.F. Hunt and R.J. Rowley by J.W. Freeman in the State aforesaid in consideration of the sum of Eight Thousand Five Hundred DOLLARS, to me in hand paid at and before the sealing of these presents by H. M. Hester (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said H. M. Hester, All that piece, parcel or lot of land in Greenville Township, Greenville

County, State of South Carolina, in Ward Five of the City of Greenville, at the Northeast corner of Arlington Ave. and Memminger Street, having the following metes and bounds, to-wit: Beginning at an iron pin on the Northeast corner of said Streets and running thence with Arlington Avenue S. 73-3/4 E. sixty feet to a stake; thence N. 16-1/4 E. one hundred ninety-three feet to a stake on the South side of a private alley; thence along said alley N. 73-3/4 W. sixty feet to an iron pin on Memminger Street; and thence with Memminger Street S. 16-1/4 W. one hundred ninety-three feet to the beginning corner, and being the same tract or lot of land conveyed to me by Wm.
