This memorandum of agreement made and entered into this 5, day of July, 1919 by and between E.C. Garrison and A.L. Garrison, parties of the first part, and W.T. Davis, party of the second part, All of the State and County aforesaid, W-I-T-N-E-S-S-E-T-H:

That for and in consideration of (\$9000.00) Nine thousand dollars, payable as hereinafter stated, E.C. Garrison and A.L. Garrison agree to convey to W.T. Davis by fee simple title with full warranty with Dowers properly renounced, a certain tract of land in Grove Township, State and County aforesaid, containing 50 acres, more or less, adjoining lands of Dr. Campbell, J.H. Charles and others and being located on the Augusta Road about 11 miles South from the City of Greenville, S.C. and being the Home Place on which the said Garrisons now reside.
