Agreement made 17th, day of October 1919, between J.D. Tannahill and Hext M. Perry, of the one part, hereinafter designated as "Tannehill and Perry", and W.D. Workman of the second part, hereinafter designated as Workman, Witnesseth:-

Whereas Tannahill and Perry own a lot of land in Greenville, South Carolina, on the east side of South Main Street, between Broad and Murphy Streets, which they desire to improve, and Workman is the owner of the next lot on the south,

Whereas it has been agreed between them that a party wall shall be erected for the use of both

Witnesseth, that Tannahill and Perry, for the consideration hereinafter mentioned, shall immediately erect a wall of the thickness of thirteen (13) inches, half upon their land and half upon Workman's, which wall shall extend one hundred feet easterly from the east side of Main Street for the first story, and fifty feet easterly from the east side of Main Street for the second story; and Workman does hereby grant to them the right to use so much of his land as is necessary for the erection of the party wall, with the understanding that hereafter he or his heirs and assigns may use the same for any building which he or they may desire to erect, upon paying onehalf of the cost of the wall.

If it should hereafter become necessary to repair or rebuild the wall or any portion thereof, the expense shall be borne equally by the parties, their heirs and assigns, as to so much and such portion of the wall as Workman, his heirs and assigns may use; and whenever any portion of the wall shall be rebuilt it shall be erected on the same spot where it is now to stand, and be of the same size and of the same or similar materials and like quality.

This agreement shall be construed as a covenant running with the land, but no part of the fee in the soil upon which the wall shall stand is deemed by this agreement to pass from one party to the other.
