Affidavit - R.E. Ward.

Personally appeared before me R.E. Ward who being duly sworn says that he is forty-two years old and is a son of Alfred Ward, and has been living on the land hereinafter described all his life and is familiar with the lines and boundaries thereof; that he was with J.B. Patterson, on September 22, 1919, when he surveyed said lands and was with him throughout the entire survey and went with him over every line shown on the plat made by Mr. Patterson on said September 22, 1919; that the beginning point on said plat is a chestnut on State Road, corner lands J.P. Surrett and that the line runs thence S. 63-½ W. 6.62 chains to a poplar on branch; thence with the branch 15 chains to walnut; thence S. 44 E. 9.25 chains to a pine; that he has examined the deed of George Potts to J.P. Surrett, dated 17th, January 1913, recorded in R.M.C. Office for State and County aforesaid in Volume 41, page 127, and by reference to said deed on record and the lines on Patterson's plat, he finds that they correspond with the lines in said deed; that William Howard now owns the Surrett land and was with the surveyor and deponent when the survey was made and recognized said lines as being correct.

That the next line on said plat is S. 30 W. 6.75 chains to a walnut; that deponent has examined the deed of Alfred Ward to Arthur Ward dated October 9, 1914, recorded in aforesaid R.M.C. Office in Vol. 27, at page 432, and finds that the lines on said plat correspond with the lines in said deed, running R.E. from walnut, corner Albert Griffin's Line to a point on Surrett line; deponent is familiar with that line and knows that it is the boundary line of Arthur Ward's land. That the next line on said plat runs as follows: R. 80 W. 14.50 chains to chestnut; thence M. 50 W. 8.50 chains to chestnut; thence M. 20 W. 16.50 chains to stake; that these three lines from the boundary. of S.M. Guest's land, and that there is no deed to S.M. Guest on record, but J.M. Guest who is a son of S.M.
