Moore referred to in said deed from Samuel Moore having thereafter married - - - Gray, and having died in February 1919, leaving as her sole surviving children, the Grantor and the Grantees herein (and no child or children of any deceased child); the said lands under the terms of said deed became vested in the Grantor and Grantees herein.

Together with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the said Thos. G. Gray and Millie G. Ransom, their heirs and assigns forever.
