Indenture made this 7th, day of Movember, 1919, between the Professional Building Company, a corporation, hereinafter called the lessor, which expression shall include it's assigns where the context so requires or admits, of the one part; and of M.H. Simon, doing business as Simon Auto Company, hereinafter called the lessee, which expression shall include his executors, administrators, heirs and assigns, where the context so requires or admits, of the other part. The said lessor does hereby lease and devise unto the said lessee the entire first floor of the Professional Building Company, situate at the northeast corner of Morth and Brown Streets, City of Greenville, for the term of five years, said term to commence immediately upon completion of the building which is now being erected at said location, it being understood that said building will be completed on or about January 1st, 1920, but there being no guaranty to this effect.

The said lessee, in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of two hundred (\$200.00) Dollars per calendar month, same being payable at the end of each month, for the first three years; and the sum of two hundred and fifty (\$250.00) dollars per calendar month, payable the end of each month, for the fourth and fifth years.

It is agreed that the lessor shall change and rearrange the front doors in such a way as may be desired by the lessee, said rearrangement to be made at once, and at the beginning of his tenancy. It is further agreed that the lessor shall have the floor tiled for a distance of thirty feet from the front the entire width of the first floor.

It is further agreed that a credit shall be given on the first rent due to the amount of three hundred (5300.00) dollars to the lessee, which amount shall be used by the lessee in fixing or finishing an office.

It is further agreed that, as the premises rented herein are to be used by the lessee for the sale of automobiles and accessories, should the fire insurance on the building of the lessor be increased by reason of the character of the business of the lessee, that the lessee will be responsible and will pay the increased insurance premiums of the lessor on said building. Any improvement on said building other than herein stated shall be made by the lessee at his own expense.

To have and to hold the said premises unto the said lessee, his executors, administrators and assigns, for the said term.

It is agreed that the destruction of the premises by fire, or other casualty, or sixty days arrear of rent, shall terminate this lease at the option of the lessor.

The lessee agrees to make good all breakage of glass excepting of plate glass in front and all other injuries done to the premises for the term except such as are produced by natural decay, and agrees to make no repairs or alterations in the premises without the written consent of the lessor.

It is further agreed that this lease shall neither be assigned or sublet without the written consent of the lessor first had and obtained.
