KNOW ALL MEN BY THESE PRESENTS, That I, Robert D. Walker of the County of Greenville and of the State aforesaid, in consideration of the sum of Twenty Hundred and Fifty (\$250.00) and no more DOLLARS, to me in hand paid at and before the sealing of these presents by Henry Briggs

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Henry Briggs. All that piece parcel and lot of land situate lying and being in the State of South Carolina, and being in the following shape and bounds to wit: Beginning at a stake of Jenkins Street formerly William Street at corner of lot No. 2, and run thence S. 15° W. 61° 56' to a stake on an alley, thence along said alley S. 75° E. 154' to an iron pin on alley, thence N. 15° E. 36' to an iron pin on Jenkins Street, thence N. 75° W. 57' to the beginning corner, containing one acre more or less. One half interest in said lot was conveyed to me by Edward Walker by his deed bearing date the 19th day of July 1912, which is recorded in the office of Register Messrs. (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

J. E. Burden, his heirs and assigns: All that certain lot or parcel of land situate, lying and being in the State and County aforesaid, about two miles west of the city of Greenville, and being known as lot no. 47 of Monaghan Alley, as shown by plat of record in the R.M.C.
