(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

J. P. Ballenger and M. A. Smith, all that certain piece, parcel or
tract of land situate, lying and being in Greenville County,
State of South Carolina, on the Southwestern slope of Parke
Mountain, in Parke Mountain Township, and more particularly
described as follows: Beginning at a stone, at the south
western corner of tract #1 (owned by M. G. Hall) and running
thence with line of said M. G. Hall N. 36° 10' E. 1709 ft. to a
China tree, corner of C. O. Hobbs land; thence along
line of said C. O. Hobbs N. 74° 30' W. 668 feet to a stone,
joint corner with Smith's land; thence along line of
said Smith's land S. 4° 0' W. 1307 ft. to a staked corner,
31-30 W. 332 ft. to a stake; thence S. 56° 50' E. 515 ft. to the
beginning corner and second corner and designated as
tract #2 & 3 and 4 of the J. D. Hubbard property, containing
19.36 acres more or less as shown on plat of said J. D.
Hubbard survey prepared by R. E. Dalton, Engineer, February
