Greenville County and in the State aforesaid,
in consideration of the sum of Eighty five DOLLARS,
to Ms in hand paid at and before the sealing of these presents by
F. M. Todd of Simpsonville
(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

F. M. Todd, All that certain piece parcel or lot of land
situate lying and being in the Town of Simpsonville,
County and State aforesaid and known as lot no. Fifty
in Block H fronting 90 feet on Hedge Street and running
back one hundred and fifty feet to Block A.
The above lot in a plat of land known as "South Side"
in a survey made by W. A. Adams, November 2nd. 1916
and recorded in the office of R. M. C. for Greenville
County in Plat Book E, page 15.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said F. M. Todd and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said F. M. Todd and his heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
