All that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State aforesaid, near the corporate limits of the City of Greenville, and being the portion of a subdivision known as "Overbrook Land Co.",

Beginning at a stake on Spartanburg road, joint corners of lots numbers thirty-five and thirty-six, and running thence in a southeasterly direction with said road, eighty feet (80') to a stake, joint corners lots numbers thirty-four and thirty-five; thence with joint lines of said lots in an easterly direction 167.2 feet to an iron pin on ten foot alley; thence in a northerly direction on line of said alley 64 feet to an iron pin, joint corners of lots numbers thirty-five and thirty-six; thence with said joint lines in a westerly direction 160.4 feet to a stake at the beginning corner, and being known as lot number thirty-five, according to a plat made by H. Olin Jones, September, 17, 1913, same being recorded in the office of R. M. C. Greenville County, and being the same lot conveyed to me by H. L. Todd, by deed dated November 29, 1916.
